2. Essential requirements for admission

Successful completion of a qualification equivalent to at least an Australian Senior Secondary Certificate of Education to Year 12 or international equivalent.

Completion of an Australian Bachelor degree or equivalent

For prospective students without a Bachelor degree, entry is allowable based on equivalent, relevant professional work experience. Prospective students without a Bachelor degree must demonstrate that they have gained skills and knowledge equivalent to an AQF7 qualification through their work experience. This will require evidence of a minimum of two years full-time work experience through a CV which provides details of employment including key duties, responsibilities and achievements which demonstrate meeting the knowledge, skills and application of skills equivalent to a Bachelor degree and AQF level 7. This will be accompanied by an entrance interview by the course coordinator

English – IELTS (Academic 6.5 with no band lower than 6.0 or equivalent)
